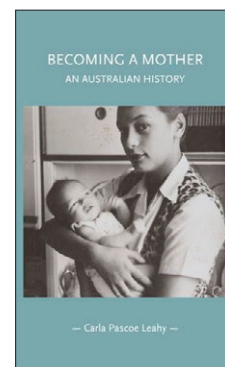

Drawing upon interdisciplinary insights from anthropology, history, psychology and sociology, Carla Pascoe Leahy unpacks this multifaceted rite of passage through more than 60 oral history interviews, demonstrating how maternal memories continue to influence motherhood today.

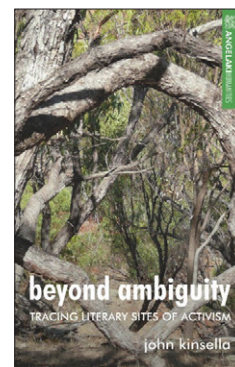


This volume completes John Kinsella's trilogy of critical activist poetics, begun two decades ago.

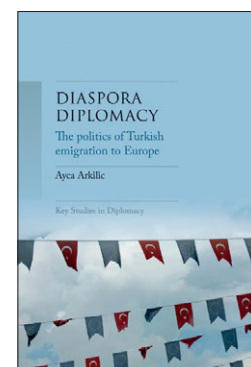


Since the early 2000s, Turkey has shown an unprecedented interest in its diaspora.

This book provides the first in-depth examination of the institutionalisation of Turkey's diaspora engagement policy since the Justice and Development Party's rise to power in 2002, the Turkish diaspora's new role as an agent of diplomatic goals, and how Turkey's growing sphere of influence affects intra-diaspora politics and diplomatic relations with Europe. The book is based on fieldwork in Turkey, France and Germany, and interviews conducted with diaspora organisation leaders and policymakers.

Diasporas have become transformative for relations at the state-to-state level and blur the division between the domestic and the foreign. A case study of Turkey's diasporas is significant at a time when emigrants from Turkey form the largest Muslim community in Europe.

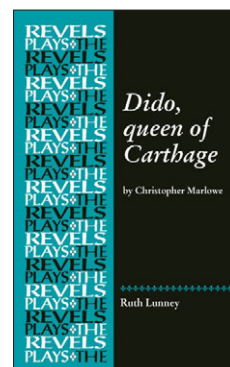


A city burns, and a queen burns for love: *Dido, Queen of Carthage* re-imagines one of the great legendary stories.

In the late eighteenth-century, elite British women had an unprecedented opportunity to travel. *Taking travel home* uncovers the souvenir culture these women developed around the texts and objects they brought back with them to realise their ambitions in the arenas of connoisseurship, friendship and science.

Key characters include forty-three-year-old Hester Piozzi (Thrale), who honeymooned in Italy; thirty-one-year-old Anna Miller, who accompanied her husband on a Grand Tour; Dorothy Richardson, who undertook various tours of England from the ages of twelve to fifty-two; and the sisters Katherine and Martha Wilmot, who travelled to Russia in their late twenties. The supreme tourist of the book, the political salon hostess Lady Elizabeth Holland, travelled to many countries with her husband, including Paris, where she met Napoleon, and Spain during the Peninsular War.

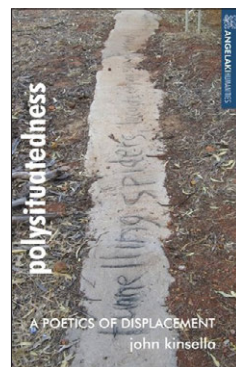
A poetics of displacement

It provides alternative readings of writers through place and space, especially Australian writers, but also non-Australian. Further, close consideration is given to being of 'famine-migrant' Irish heritage and the complexities of 'returning'.

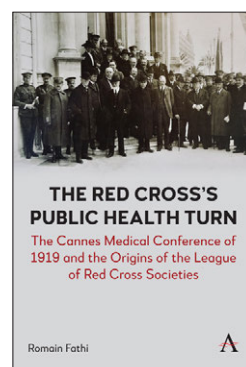

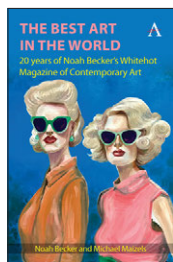

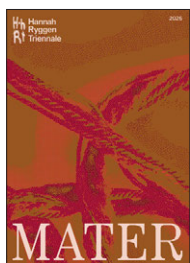

PAINTING HER PLEASURE

Three women artists and the nude in avant-garde Paris

This book examines nudes by three women: Suzanne Valadon, Émilie Charmy and Marie Vassilieff.

Working in avant-garde Paris, these artists pioneered modern body imagery, expressing female subjectivity and sexuality in paint. They experimented with the male nude, Black female nude, pregnant nude and nude self-portrait, a genre which few artists tackled until half a century later.

Flouting the period's scientific discourses and social mores, they breached assumptions about 'feminine' art and unhinged expectations about the type of subject a woman could paint. They simultaneously defied prevailing academic and vanguard practices, forging new artistic methods for the representation of the body informed by an acute awareness of self.

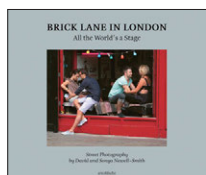

FOLK HORROR ON FILM

What is folk horror and how culturally significant is it? This collection is the first study to address these questions while considering the special importance of British cinema to the genre's development.

The book presents political and aesthetic analyses of folk horror's uncanny landscapes and frightful folk. It places canonical films like *Witchfinder General* (1968), *The Blood on Satan's Claw* (1971) and *The Wicker Man* (1973) in a new light and expands the canon to include films like the sci-fi horror *Doom watch* (1970-72) and the horror documentary *Requiem for a Village* (1975).

A series of engrossing chapters by established scholars and new writers argue for the uniqueness of folk horror from perspectives that include the fragmented national history of pagan heresies and Celtic cultures, of peasant lifestyles, folkloric rediscoveries and postcolonial decline.

During the negotiations over Hong Kong's future, British diplomats aimed to educate the Chinese in free-market capitalism.

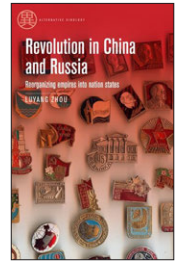

Most scholars believe that China's nationality policy, like that of other socialist states, imitated the Soviet nationality model, a system which has been termed an 'affirmative action empire'.

This book offers two contributions to the literature which run counter to this convention. First, it argues that the People's Republic of China (PRC) and the Soviet Union (USSR) were different; while the PRC was aimed to build an ideal-typical nation-state, the USSR was an open union of nation-states that was only temporarily confined to a physical territory. Second, while scholars who have noted this difference attribute it to contextual factors, such as ethnic structure, geopolitical status, and Russia's intervention into the Chinese Revolution, this book contends that context shaped the Sino-Soviet difference, yet it did not determine it.
